## **TERMINATION OF SECURITY INTEREST IN TRADEMARKS AND PATENTS**

WHEREAS, the Grantor (a) entered into that certain Loan and Security Agreement dated as of May 26, 2017 (as at any time amended, restated, supplemented or otherwise modified, the "**Agreement**"), between the Grantor and ACF FINCO I LP, a Delaware limited partnership ("**Secured Party**"), (b) executed and delivered to Secured Party a Memorandum and Notice of Security Interest in Intellectual Property dated May 26, 2017 (the "**Memorandum**"), a true and correct copy of the Memorandum which was recorded by the United States Patent and Trademark Office on May 31, 2017, at Reel 6073, Frame 0947, and (c) executed and delivered to Secured Party a Supplement No. 1 to Memorandum and Notice of Security Interest in Intellectual Property dated October 19, 2020 (the "**Memorandum Supplement**", and together with the Agreement and the Memorandum, the "**Security Documents**"), a true and correct copy of the Memorandum Supplement which was recorded by the United States Patent and Trademark Office on October 22, 2020, at Reel 54188, Frame 0151;

WHEREAS, the Secured Party desires to release its security interest in the Trademarks and Patents and terminate the Memorandum and the Memorandum Supplement;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby:

1. Releases and reassigns to the Grantor any and all liens, security interests, right, title and interest of Secured Party pursuant to the Security Documents in the trademarks and applications more fully described on Exhibit A, without recourse or representation or warranty, express or implied; and
2. Releases and reassigns to the Grantor any and all liens, security interests, right, title and interest of Secured Party pursuant to the Security Documents in the patents and applications more fully described on Exhibit B, without recourse or representation or warranty, express or implied; and
3. Authorizes and requests the Commissioner of Patents and the Commissioner of Trademarks of the United States of America to note and record the existence of the releases hereby given.


