2. all income, royalties, and damages hereafter due or payable to Assignor with respect to the Assigned IP, including without limitation, damages, and payments for past, present, or future infringements and misappropriations of the Assigned IP;
3. all rights to sue for past, present and future infringement or misappropriations of the Assigned IP;
4. all rights arising by filing of applications for registration of the Assigned IP in this or another country, or arising by operation of any statute or treaty of the United States (or any state thereof) or any other country; and
5. the goodwill associated with or symbolized by any of the foregoing, including the goodwill of the business relating to the products and services on which the Trademarks or other Assigned IP are used.

The Assignor further covenants that it will take all actions that may be necessary for securing, completing, or vesting in the Assignee full right, title, and interest in the Assigned IP and its related property.

To the extent that a *nunc pro tunc* assignment is contrary to applicable law, then Assignor hereby unconditionally and irrevocably grants, assigns and conveys to Assignee all of the above rights as of the last date set forth below.
