**TERMINATION AND RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of November 17, 2023 (“Release”), is made by **DEERPATH FUND SERVICES, LLC**, a Delaware limited liability company, (“Bank”), in favor of **FUSIONSITE CHARLOTTE LLC**, a Delaware limited liability company (“Pledgor”).

WHEREAS, pursuant to that certain Loan Agreement, dated as of April 22, 2022 (the “Loan Agreement”), by and between Bank and Pledgor and (ii) that certain Patent and Trademark Security Agreement dated as of September 30, 2022 by and between Pledgor and Bank (the “IP Agreement”), the Pledgor granted and conveyed to Bank a security interest in the entire right, title and interest of Pledgor in and to all of Pledgor's Patents, Trademarks and Copyrights;

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Bank agrees as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Loan Agreement or IP Agreement, as applicable.

SECTION 2. Termination and Release. Bank, without representation, warranty, or recourse, hereby:

(a) (i) terminates the IP Agreement and (ii) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the entire right, title, and interest of the Pledgor in and to all of Pledgor's Patents, Trademarks and Copyrights, including, but not limited to, the foregoing listed on Schedule A attached hereto and the IP Collateral (as defined in the IP Agreement), granted pursuant to the Loan Agreement and the IP Agreement, and with respect to the Trademarks, such release shall include the goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

(b) authorizes the recordation of this Release with the USPTO and the Copyright Office, as applicable, at Pledgor’s expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York, without regard to its conflict of laws principles.
