SpeedGauge, Inc., a corporation organized and existing under and by virtue of the provisions of the General Corporation Law of the State of Delaware (the "*General Corporation Law*"), does hereby certify:

ONE: That the name of this corporation is SpeedGauge, Inc. (the "*Company*").

TWO: The original Certificate of Incorporation of the Company was filed with the Secretary of State of the State of Delaware on June 25, 2002 under the name LandSonar, Inc.

THREE: Pursuant to Sections 141 and 242 of the General Corporation Law, this Certificate of Amendment to the Certificate of Incorporation (this "*Certificate of Amendment*") amends the Company's Amended and Restated Certificate of Incorporation (the "*Certificate of Incorporation*") as follows:

Article I of the Certificate of Incorporation is amended and restated in its entirety to read as follows:

FOUR: This Certificate of Amendment has been duly adopted in accordance with Sections 141 and 242 of the General Corporation Law.
