

This Instrument Witnesseth That the Board of Regents for and on behalf of the Education Department of the State of New York at their meeting of April 12, 2022,

An application having been made by and on behalf of the trustees of Iona College, for an amendment of its charter, it was

<u>Voted</u>, that the provisional charter of Iona College, located in New Rochelle, county of Westchester, state of New York, which was granted by action of the Board of Regents on July 19, 1940; which provisional charter was extended by Regents action on September 21, 1945 and was made absolute by Regents action on May 16, 1947; which absolute charter was amended was amended on various occasions with the last amendment being granted on November 5, 1999 be, and the same hereby is, amended to change the corporate name to "Iona University" effective July 1, 2022.
