## RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “Release”) is made as of September 1, 2023, by **VALLEY NATIONAL BANK**, a national banking association, as successor by merger to Bank Leumi USA (“Lender”).

### RECITALS:

WHEREAS, Recurrent Ventures Inc. (“Recurrent”), Acton Media Inc. (“Acton”), Brookline Media Inc. (“Brookline”), Camden Media Inc. (“Camden”), Dover Media Inc. (“Dover”), Donut Media, Inc. (“Donut”), and Livingly Media, Inc. (“Livingly” and together with Recurrent, Acton, Brookline, Camden, Dover, and Donut, individually and collectively, as the context requires, but in each case jointly and severally, “Pledgor”), and Lender, entered into that certain Intellectual Property Security Agreement dated as of January 21, 2022 (the “Security Agreement”), pursuant to which Pledgor granted to Lender a security interest in and to and lien upon certain intellectual property and related rights owned by Pledgor;

WHEREAS, an executed copy of the Security Agreement was recorded in the United States Patent and Trademark Office on March 15, 2022; and

WHEREAS, Pledgor has requested that Lender release, and Lender has agreed to release, its lien on certain intellectual property pledged pursuant to the Security Agreement as identified herein.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Lender hereby agrees as follows:

### AGREEMENT:

Capitalized terms used but not defined herein shall have the respective meanings given thereto in the Security Agreement.

Lender hereby releases and terminates all right, title and interest pledged, hypothecated, assigned, transferred, deposited and granted to it by Pledgor pursuant to the Security Agreement in all intellectual property, including, without limitation, the patent and copyright identified on Schedule A annexed hereto (collectively, the “Released Collateral”), and all liens, security interests, charges or other encumbrances in favor of Lender in the Released Collateral shall hereby terminate and revert to Pledgor and all right, title and interest of Lender in the Released Collateral will hereby cease, terminate and become void.
