RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS

THIS RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS, dated as of November 17, 2023, (this “*Release*”) is made by SENIOR CREDIT (UWF) LLC, a Delaware limited liability company, as Collateral Agent acting for the benefit of the Secured Parties (in such capacity, “*Collateral Agent*”) under the Grant of Security Interest in Trademark Rights (as amended, supplemented or modified and in effect from time to time, the “*Trademark Security Agreement*”), between EXOSTAR LLC, a Delaware limited liability company, (the “*Grantor*”) and the Collateral Agent. Capitalized terms used but not defined herein have the meanings provided in the Trademark Security Agreement.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded at the United States Patent and Trademark Office on July 7, 2020 at Reel 6991 and Frame 0583, the Grantor granted to the Collateral Agent a continuing security interest in all of Grantor’s right, title and interest in Trademarks, including those set forth on the attached Schedule A, together with the goodwill of the business symbolized by Grantor’s Trademarks.

WHEREAS, Grantor has requested and the Collateral Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the “*Released Collateral*”).


NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to the Collateral Agent in the Released Collateral, and (d) reassigns, grants and conveys to Grantor any and all right, title and interest it has in the Released Collateral.

This Release shall be governed by, and construed and interpreted in accordance with the laws of the State of New York.
