DECLARATION

I, Johanna Schmitt, declare as follows:

1. I submit this declaration in connection with American Sports Licensing, LLC's registration for the word mark TOP-FLITE D2 in International Class 28 for "Golf balls" (Reg. No. 3,263,233) (the "Registration") for which I am Attorney of Record. This declaration is based on my personal knowledge and review of trademark records, and is made to the best of my knowledge, information, and belief.

2. I was appointed as Attorney of Record for the Registration on April 14, 2021.

3. On July 10, 2007, Callaway Golf Company was issued the Registration.

4. On July 9, 2013, Callaway Golf Company filed a document evidencing the Assignment of the Registration to American Sports Licensing, Inc. (Reel/Frame: 5065/0750). Thus, the owner of the Registration was correctly updated on the record to American Sports Licensing, Inc.

5. On August 3, 2016, American Sports Licensing, Inc. filed a Certificate of Merger document evidencing the merger of American Sports Licensing, Inc. with and into American

Sports Licensing, LLC (Reel/Frame: 5845/0406). Thus, the owner of the Registration was correctly updated on the record to American Sports Licensing, LLC. It is the current owner of the Registration.


6. On September 7, 2022, Callaway Golf Company filed a Certificate of Amendment to the Second Restated Certificate of Incorporation of Callaway Golf Company evidencing the Change of Name from Callaway Golf Company to Topgolf Callaway Brands Corp. (Reel/Frame: 7844/0836) (the "Topgolf Change of Name Filing"). As a result, the owner of the Registration was incorrectly updated on the record to Topgolf Callaway Brands Corp.

7. At the time the Topgolf Change of Name Filing as filed, the current owner of the Registration was correctly listed as American Sports Licensing, LLC and thus the Topgolf Change of Name Filing improperly broke the chain of title for the Registration and was filed without the knowledge of American Sports Licensing, LLC.

8. American Sports Licensing, LLC requests that the Topgolf Change of Name Filing be removed from the record and proper ownership of the Registration be restored to American Sports Licensing, LLC on the record.

I declare that, to the best of my knowledge and belief, the information herein is true and complete. I understand this statement is made for use as evidence in court and is subject to penalty for perjury.
