**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of November 8, 2023 in favor of SPM Marketing & Communications, LLC, a Delaware limited liability company (“Grantor”) (as successor by assignment to Dreamscape Marketing, LLC, a Maryland limited liability company (“Dreamscape”)), by The Huntington National Bank (successor by merger to TCF National Bank) (“Lender”).

WHEREAS, pursuant to the terms and conditions of that certain Patent, Copyright and Trademark Security Agreement dated as of September 10, 2021 (the “Security Agreement”) executed by Dreamscape in favor of Lender, Dreamscape granted to Lender a security interest in all of Dreamscape’s right, title and interest in and to the trademark applications and registrations set forth on Schedule 1 attached hereto (collectively the “Trademarks”);

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on September 13, 2021 at Reel/Frame 7419/0968.

WHEREAS, pursuant to the terms and conditions of that certain Assignment, dated February 11, 2022 (the “Assignment”), Dreamscape assigned to Grantor all of Dreamscape’s right, title and interest in and to the Trademarks;

WHEREAS, the Assignment was recorded with the United States Patent and Trademark Office on May 18, 2022 at Reel/Frame 7715/0070;

WHEREAS, Lender wishes to release its security interest in the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby terminates the Security Agreement and hereby terminates, cancels and releases any security interest it may have in the Trademarks.

Lender shall take all further actions, and provide to Grantor and Dreamscape all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor and Dreamscape to more fully and effectively effectuate the purposes of this Release. Grantor is hereby authorized to file and record this Release with the appropriate governmental agency or authority as evidence of the release of security interest granted hereunder.
