RELEASE OF SECURITY INTERESTS IN TRADEMARKS

WHEREAS, the Grantor has, pursuant to that certain Trademark Security Agreement dated as of July 10, 2018, recorded in the United States Patent and Trademark Office (the "USPTO") on July 24, 2018 at Reel 6412, Frame 0432 (as the same may be amended, amended and restated, restated, supplemented, modified or otherwise in effect prior to the date hereof, the "Trademark Security Agreement") granted to the Administrative Agent, on behalf of the Secured Parties, a Security Interest in and to all of such Grantor's right, title and interest, including goodwill, in and to the Trademark Collateral, including without limitation those trademarks listed on Exhibit A attached hereto (collectively, the "Released Collateral"); and

B. WHEREAS, the Administrative Agent wishes to terminate and release, without representation or warranty, its Security Interest in and to the Released Collateral as provided in this Release.

C. NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent hereby terminates, discharges, cancels, and releases, without recourse, representation or warranty, the entirety of any and all liens or Security Interest it has in and to the Released Collateral, including all claims, whether presently existing or hereafter acquired or created, pursuant to the Trademark Security Agreement, and terminates the Trademark Security Agreement. If and to the extent that the Administrative Agent has acquired any right, title or interest in and to the Released Collateral, the Administrative Agent hereby assigns, transfers and conveys any and all right, title or interest of the Administrative Agent in the Released Collateral to the Grantor, and any right, title or interest of the Administrative Agent in such Released Collateral shall hereby terminate, cease and become void. The Administrative Agent acknowledges that this Release may be filed along with any other necessary documentation with the USPTO or any other governmental office to evidence the release granted herein at the sole expense of the Grantor. The Administrative Agent authorizes the Grantor to record this Release with the USPTO and other applicable registry at the sole expense of the Grantor and agrees to provide the Grantor with any information and additional authorization necessary to effect the release of the Security Interest in the Released Collateral.
