RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of November 21, 2023, is made by LBC SMALL CAP SBIC, L.P. (the "*Agent*") in favor of, as applicable, SHIPWARE, LLC, a California limited liability company ("*Shipware*"), SIB DEVELOPMENT & CONSULTING, INC., a Delaware corporation ("*SIB Development*"), and GETIDA LLC, a New Jersey limited liability company ("*Getida*"; and together with Shipware and SIB Development, each a "*Grantor*" and, collectively, the "*Grantors*").

WHEREAS, pursuant to the Security Agreement dated as of April 10, 2020 (as amended and restated by that certain Amended and Restated Security Agreement, dated as of July 20, 2022, and as further amended, modified or supplemented from time to time, the "*Security Agreement*"), by and among each Grantor, the other "Debtors" (as defined therein) party thereto and the Agent, each Grantor pledged, collaterally assigned and granted to the Agent a security interest in all of such Grantor's right, title and interest in the "Collateral" (as defined therein), including the trademarks set forth on Schedules 1, 2, and 3 attached hereto (the "*Trademarks*"); and

WHEREAS, pursuant to (i) that certain Trademark Security Agreement, dated as of April 10, 2020, by and between the Agent and SIB Development, which was duly recorded on April 10, 2020 at Reel 6913, Frame 0517 in the United States Patent and Trademark Office (the "*SIB Security Agreement*"), SIB Development granted to the Agent, to secure its obligations under the Security Agreement, a security interest in all right, title and interest of SIB Development in and to certain intellectual property, (ii) that certain Trademark Security Agreement, dated as of February 25, 2022, by and between the Agent and Shipware, which was duly recorded on March 2, 2022 at Reel 7648, Frame 0571 in the United States Patent and Trademark Office (the "*Shipware Security Agreement*"), Shipware granted to the Agent, to secure its obligations under the Security Agreement, a security interest in all right, title and interest of Shipware in and to certain intellectual property and (iii) that certain Trademark Security Agreement, dated as of July 20, 2022, by and between the Agent and Getida, which was duly recorded on July 22, 2022 at Reel 7798, Frame 0019 in the United States Patent and Trademark Office (the "*Getida Security Agreement*" and together with the SIB Security Agreement, and the Shipware Security Agreement, each a "*Trademark Security Agreement*" and, collectively, the "*Trademark Security Agreements*"), Getida granted to the Agent to secure its obligations under the Security Agreement, a security interest in all right, title and interest of Getida in and to certain intellectual property; and

WHEREAS, the Agent wishes to release and restore all right, title and interest in the Trademarks to the applicable Grantor and to dissolve those liens and encumbrances created by each Trademark Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under each Trademark Security Agreement in the Trademarks, (b) release its security interest in the Trademarks, and (c) discharge any and all rights, title and interest it has in and the security interest granted to Agent in the Trademarks.

Agent shall take all further actions, and provide to each Grantor and its respective successors, assigns or other legal representatives, such cooperation and assistance (including, without limitation, the execution and delivery of any documents or other instruments), reasonably requested by such Grantor, and at such Grantor's cost and expense, to more fully and effectively effectuate the release of liens contemplated hereby. Agent hereby authorizes and requests that the United States Patent and Trademark Office note and record the present Release of Security Interest in Trademarks.


