TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT (this "Release") is made as of November 20, 2023, by TRC DEBTCO, LLC, in its capacity as administrative agent for the Secured Creditors ("Agent") in favor of THERAPEUTIC RESEARCH CENTER, LLC, a Delaware limited liability company (the "Grantor"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Trademark Security Agreement (as defined below).

WITNESSETH:

WHEREAS, the Grantor and Agent were parties to that certain Second Lien Trademark Security Agreement dated as of March 21, 2019 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement") and the Security Agreement pursuant to which the Grantor granted a continuing security interest to Agent in certain Trademarks and Trademark Collateral (as defined below) as security for certain obligations owing by the Grantor to Agent, including the Trademarks set forth on Schedule A attached hereto;

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on March 21, 2019, at Reel 6597, Frame 0608;

WHEREAS, the Grantor has requested that Agent terminate the Trademark Security Agreement, terminate the Security Agreement, and terminate and release its continuing security interest in the Trademarks and Trademark Collateral and reassign any and all rights in the same to the Grantor; and

WHEREAS, the Grantor has satisfied and fulfilled all of its obligations to terminate the Security Agreement and the Trademark Security Agreement and terminate and release Agent's continuing security interest in the Trademarks and Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its continuing security interest in all of the Grantor's right, title and interest in and to all Trademark Collateral, including, for the avoidance of doubt, the following:

(a) all of its Trademarks and rights in and to exclusive Intellectual Property Licenses with respect to Trademarks to which it is a party including those Trademarks referred to on Schedule A attached hereto;

(b) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark Intellectual Property License; and

(c) all products and proceeds of the foregoing, including without limitation, any claim by the Grantor against third parties for past, present or future (i) infringement or dilution of each such Trademark, or (ii) injury to the goodwill associated with each

such Trademark or any Trademark licensed under any Intellectual Property License or (iii) right to receive license fees, royalties, and other compensation under any Trademark Intellectual Property License;

2. Agent hereby reassigns, grants and conveys to the Grantor, without any representation, recourse or undertaking by Agent, any and all of Agent's right, title and interest in and to the Trademarks and the Trademark Collateral. The Agent hereby authorizes the Grantor (or its designee) to file this Release with the United States Patent and Trademark Office.

3. Agent hereby terminates the Trademark Security Agreement.

4. This Release shall be governed by, and construed in accordance with, the law of the State of New York.
