**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of November 22, 2023, by **ATHYRIUM OPPORTUNITIES IV ACQUISITION LP**, a Delaware limited partnership (in such capacity, together with its successors and assigns, “Administrative Agent”) in favor of **RVL PHARMACEUTICALS, INC.**, a Delaware corporation with an address at 400 Crossing Boulevard, Bridgewater, New Jersey 08807 (“Grantor”).

W I T N E S S E T H:

WHEREAS, Grantor entered into a certain trademark security agreement dated October 12, 2021 (the “Trademark Security Agreement”) with Administrative Agent, notice of which was recorded on October 12, 2021 at the United States Patent and Trademark Office at Reel 7449, Frame 0895.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted the Administrative Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in all of such Grantor’s right, title and interest in and to its trademarks, trademark licenses and trademark applications, including without limitation the trademarks listed in **Schedule A** (collectively, the “Trademark Collateral”).

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges (in each case, without any recourse to, or any representation or warranty by, the Administrative Agent) any and all of its interest in the Trademark Collateral of the Grantor, including all of the goodwill of such Grantor’s business symbolized by the Trademarks and associated therewith, and assigns, transfers and conveys to Grantor (in each case, without any recourse to, or any representation or warranty by, the Administrative Agent) any interest in such intellectual property, including the Security Interest and any other liens.
