**Trademark Assignment Agreement**

This **TRADEMARK ASSIGNMENT AGREEMENT** (“*Agreement*”) is effective as of June 1, 2023 (“*Closing Date*”) made between Twilio Inc., a Delaware corporation (“*Assignor*”), and KORE Wireless Group, Inc., a corporation incorporated under the Laws of Delaware (“*Assignee*”).

WHEREAS, pursuant to the Intellectual Property Matters Agreement dated as of March 26, 2023 between Assignor and Assignee (the “*IPMA*”), Assignor agreed to assign or cause to be assigned to Assignee all of Assignor’s right, title and interest in and to certain Trademarks.

NOW, THEREFORE, in consideration of the foregoing and the representations, warranties, covenants, and agreements contained in the IPMA, and for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

Capitalized terms used in this Agreement which are not otherwise defined herein will have the meanings set forth in the IPMA.

1. On the terms and subject to the conditions set forth herein, and in the IPMA, Assignor hereby assigns, transfers, and conveys to Assignee, and Assignee hereby acquires from Assignor, on a worldwide basis, all of its right, title and interest, as of the Closing Date, in and to (i) the Trademarks listed on Schedule A hereto (including those that are registered, those that are pending registration and all applications) (the “*Assigned Trademarks*”), together with the associated goodwill in the Assigned Trademarks and in the business, products, and services symbolized by the Assigned Trademarks, (ii) all rights in the foregoing provided by international treaties or conventions, (iii) all income, royalties or payments due or payable with respect to the foregoing and (iv) any and all causes of action and rights of recovery for past, present and future infringement or misappropriation of any of the Assigned Trademarks.

2. From and after the Closing Date, upon Assignee’s request and at Assignee’s sole cost and expense, Assignor shall (and shall cause its Subsidiaries to) cooperate with and use commercially reasonable efforts to take, or cause to be taken, all actions, and to do, or to cause to be done, all things reasonably necessary, proper or advisable on such Assignor’s part under applicable law to effect and validate the assignment of the Assigned Trademarks to Assignee.

3. The parties hereby authorize the relevant authority at the United States Patent and Trademark Office, or any foreign equivalent thereto, to record this Agreement. Assignee agrees that it is Assignee’s responsibility to record this Agreement.

4. This Agreement, together with the IPMA, contains the entire agreement between the parties with respect to the subject matters hereof and thereof and supersedes all prior agreements and understandings, oral or written, with respect to such matters. In the event of any conflict between this Agreement and the IPMA, the terms of the IPMA will govern.

5. This Agreement may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.
