RELEASE OF TRADEMARK SECURITY AGREEMENT

This RELEASE OF TRADEMARK SECURITY AGREEMENT (the "*Release*") is made on this 16th day of November, 2023, by CAPITALSPRING AGENCY SERVICES, LLC, a Delaware limited liability company (the "*Agent*"), as Agent for the benefit for the Lenders party to the Credit Agreement (as hereinafter defined).

R E C I T A L S

WHEREAS, LUNA GRILL RESTAURANTS LLC, a Delaware limited liability company ("*Grantor*") entered into that certain Credit Agreement dated October 25, 2016 (as amended from time to time, the "*Credit Agreement*"), by and among PREMIER FOOD CONCEPTS, LLC, a California limited liability company, Grantor, the lenders party thereto from time to time (collectively, the "*Lenders*") and the Agent, pursuant to which the Lenders extended certain financial accommodations to Grantor;

WHEREAS, a condition to entering into the Credit Agreement, the Grantor entered into that certain Trademark Security Agreement dated as of October 25, 2016 (the "*Trademark Security Agreement*") between Grantor and the Agent, and granted to the Agent on behalf of the Lenders a security interest in certain Trademark Collateral (as defined in the Trademark Security Agreement).

WHEREAS, the security interest granted to the Agent under the Trademark Security Agreement was recorded at the United States Patent and Trademark Office on October 28, 2016, at Reel 005911 and Frame 0875; and

WHEREAS, the Agent has agreed to terminate and release all of its right, title and interest in, to and under all of the Trademark Collateral.


