**ASSIGNMENT OF SECURITY INTEREST IN  
TRADEMARK COLLATERAL**

This ASSIGNMENT OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Assignment"), dated as of September 11, 2023, is entered into by and between Antares Capital LP ("Assignor") and Linden Financial, LLC ("Assignee"). All capitalized terms used herein and not otherwise defined shall have the respective meanings given to such terms in the Trademark Security Agreement referred to below, whether directly therein, or by reference to another agreement.

WHEREAS, pursuant to that certain Collateral Agreement, dated as of December 1, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Collateral Agreement") among Assignor and G.A. FOOD SERVICES OF PINELLAS COUNTY, LLC (the "Grantor") and certain other parties, the Grantor executed and delivered that certain Trademark Security Agreement, dated as of December 1, 2020 (the "Trademark Security Agreement"), pursuant to which each Grantor granted to Assignor, for the ratable benefit of the Secured Parties, a security interest in, all of the Trademark Collateral of such Grantor, including the registered trademarks and trademark applications of such Grantor listed on Schedule I hereto;

WHEREAS, Assignor recorded the Trademark Security Agreement with the United States Patent and Trademark Office on December 1, 2020 at Reel/Frame 7171/0180

WHEREAS, Assignor has resigned as collateral agent, and Assignee has been appointed as the successor collateral agent, and accordingly Assignor has assigned to Assignee, and Assignee has assumed, all of Assignor's rights and obligations under the Collateral Agreement and the Trademark Security Agreement and the security interests granted thereunder; and

WHEREAS, Assignor and Assignee desire to confirm the foregoing assignment and assumption in this Assignment for purposes of recording it with the United States Patent and Trademark Office.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor hereby assigns to Assignee, and Assignee hereby assumes, all of Assignor's right, title and interest in, to and under, the Trademark Collateral and the Trademark Security Agreement, including, without limitation, its security interest in the Trademark Collateral. The foregoing Assignment is made without recourse, representations or warranties of any kind.


