FIRST LIEN TRADEMARK RELEASE AND REASSIGNMENT

THIS FIRST LIEN TRADEMARK RELEASE AND REASSIGNMENT is made as of November 20, 2023, by BMO BANK N.A., formerly known as BMO HARRIS BANK N.A., in its capacity as Administrative Agent for itself and the other Lenders (together with its successors and assigns in such capacity, "Grantee"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement or Trademark Security Agreements (each as defined below), as applicable.

WITNESSETH:

WHEREAS, pursuant to that certain First Lien Guaranty and Security Agreement, dated as of April 22, 2015 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement") by and among Grantee, SHOCK DOCTOR, INC., a Delaware corporation ("Shock Doctor"), MCDAVID, INC., an Illinois corporation ("McDavid"), DASHAMERICA, INC., a Colorado corporation ("DashAmerica"); and together with Shock Doctor and McDavid, each a "Grantor" and, collectively, the "Grantors") and certain other parties thereto, Grantors granted to the Grantee, in its capacity as Administrative Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, (i) Shock Doctor and McDavid executed and delivered that certain First Lien Trademark Security Agreement, dated as of April 22, 2015, (ii) Shock Doctor executed and delivered that certain First Lien Trademark Security Agreement, dated as of October 23, 2015, (iii) Shock Doctor executed and delivered that certain First Lien Trademark Security Agreement, dated as of August 23, 2019, and (iv) DashAmerica executed and delivered that certain First Lien Trademark Security Agreement, dated as of March 3, 2023 (each, a "Trademark Security Agreement" and collectively, the "Trademark Security Agreements"), pursuant to which Grantors mortgaged, pledged and hypothecated to the Grantee for the benefit of the Secured Parties and granted to the Grantee for the benefit of the Secured Parties a Lien on and security interest in, all of its right, title and interest in, to and under the Trademark Collateral (as defined below) as security for certain obligations owing by Grantors to Grantee, including the trademarks set forth on Schedule A hereto;

WHEREAS, the Trademark Security Agreements were recorded by the Trademark Assignment Branch of the United States Patent and Trademark Office on April 23, 2015, at Reel 5505, Frame 0253, October 23, 2015, at Reel 5651, Frame 0958, August 23, 2019, at Reel 6727, Frame 0880, and March 3, 2023, at Reel 7992, Frame 0001, respectively;

WHEREAS, Grantors have requested that Grantee release its security interest in the Trademark Collateral and reassign any and all rights in the same to the applicable Grantor;

WHEREAS, Grantors have satisfied and fulfilled all of its obligations to release the Grantee's security interest in the Trademark Collateral; and

WHEREAS, Grantee has agreed to irrevocably and fully terminate, release and discharge its entire security interest and lien in all of the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee, on behalf of itself and the Secured Parties, their successors, legal representatives and assigns, hereby automatically, irrevocably and fully terminates the Trademark Security Agreements

and automatically, irrevocably and fully terminates, releases and discharges any and all Liens and security interests that it has pursuant to the Trademark Security Agreements in all of its right, title and interest in, to and under the Trademark Collateral of the Grantors, and reassigns to the applicable Grantors all of its right, title and interest in, to, and under the following (collectively the "Trademark Collateral"):

(i) all of its trademarks, including, without limitation, those referred to on Schedule A hereto;

(ii) all renewals and extensions of the foregoing;

(iii) all goodwill of the business connected with the use of, and symbolized by, each such trademark; and

(iv) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

2. Grantee hereby automatically and irrevocably releases, grants and conveys to the applicable Grantors, without any representation, recourse or undertaking by Grantee, any and all Grantee's right, title and interest in and to the Trademark Collateral.

3. This First Lien Trademark Release and Reassignment and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.
