TRADEMARK ASSIGNMENT

This Trademark Assignment (the "Assignment") is made as of March 1, 2023 by **JMC Restaurant Holdings, L.L.C.**, an Arizona limited liability company ("Assignor") in favor of **JMC Restaurant Holdings International, L.L.C.**, an Arizona limited liability company ("Assignee").

RECITALS

WHEREAS, Assignor is the owner and filer of United States trademark registrations **Reg. No. 6,716,747** for the trademark GRIMALDI'S COAL BRICK-OVEN PIZZERIA TO-GO (the "Registration"); and

WHEREAS, Assignor and Assignee agree to assign to Assignee all of Assignor's right, title, and interest in the Registration, together with all Assignor's claimed rights, use, and goodwill in the trademark GRIMALDI'S COAL BRICK-OVEN PIZZERIA TO-GO.

NOW, THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged, and subject to the conditions and obligations contained herein, the Parties agree to the following:

AGREEMENT

1. **Assignment.** Assignor does hereby assign, transfer, and set over to Assignee, Assignor's entire right, title, and interest in and to the Registration, together with all Assignor's claimed rights, use, and goodwill in the trademarks GRIMALDI'S COAL BRICK-OVEN PIZZERIA TO-GO for the United States and for all foreign countries, including any renewals or extensions thereof that are or may be secured under the laws of the United States or foreign countries now or hereafter in effect.

2. **Full Authority.** Assignor represents and warrants it has full power, authority, and legal right to execute this Assignment. Moreover, Assignor represents it has not executed this Assignment, or any document required to be executed pursuant to this Assignment, under any duress, under pressure, or fraud and that it is legally and equitably bound by the express terms, or representations, warranties, covenants, and conditions contained herein.

3. **Binding Effect.** This Agreement is binding upon the Assignor and its respective successors, assigns, parent companies, subsidiaries, affiliates, members, managers, and/or other related persons or entities.

4. **Governing Law.** This Agreement is governed, controlled, interpreted, and defined by and through the laws of the State of Arizona without regard to the conflicts of law provisions thereof.
