TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this “**Termination and Release**”) is granted as of October 24, 2022, by **SILICON VALLEY BANK**, as administrative agent (“**Administrative Agent**”) in favor of **SKILL SURVEY, INC.**, a Delaware corporation (“**Grantor**”).

WHEREAS, the Grantor executed and delivered a Trademark Security Agreement, dated as of April 6, 2018 (the “**Agreement**”), granting to the Administrative Agent a security interest in all of its right, title and interest, whether presently existing or hereafter acquired, in, to and under the Trademarks (as defined in the Agreement), notice of which was recorded with the United States Patent and Trademark Office (“**USPTO**”) on April 6, 2018 at Reel 6308, Frame 0545;

WHEREAS, the Grantor executed and delivered a First Supplement to Trademark Security Agreement, dated as of November 26, 2019 (the “**Supplement**”), granting to the Administrative Agent a security interest in all of its right, title and interest, whether presently existing or hereafter acquired, in, to and under the Trademarks (as defined in the Supplement), notice of which was recorded with the USPTO on November 26, 2019 at Reel 6804, Frame 0807;

WHEREAS, Grantor has requested that Administrative Agent hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Trademarks as herein provided; and

WHEREAS, Grantor has requested that the Administrative Agent provide a document suitable for recording with the USPTO to evidence the release of the Administrative Agent’s security interests in and liens on the Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby:

1. terminates the Agreement and Supplement and releases, terminates and discharges fully all liens and security interests thereunder in Grantor’s right, title and interest in, to and under the Trademarks, including, without limitation, those trademarks and trademark applications identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.
