## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of November 27, 2023 (the “Effective Date”), is made by JPMorgan Chase Bank, N.A., in its capacity as Collateral Agent (the “Collateral Agent”, as successor to Credit Suisse AG, Cayman Islands Branch, the “Prior Collateral Agent”), in favor of the pledgor parties identified on the signature page hereto (each, a “Pledgor” and, together the “Pledgors”).

WHEREAS, pursuant to that certain Security Agreement, dated as of May 22, 2017, by and among the Collateral Agent (as successor to the Prior Collateral Agent), the Pledgors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Security Agreement”), the Pledgors granted to the Collateral Agent, in its capacity as Collateral Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, the Pledgors executed and delivered to the Prior Collateral Agent a Trademark Security Agreement, dated as of May 22, 2017 (the “First Trademark Security Agreement”), for recordal with the United States Patent and Trademark Office;

WHEREAS, pursuant to that certain Notice of Succession of Agency, dated May 6, 2019, by and between the Collateral Agent and the Prior Collateral Agent (the “Notice of Succession of Agency”), the Prior Collateral Agent assigned, transferred, set over and delivered to the Collateral Agent the security interest in certain collateral under the First Trademark Security Agreement, for recordal with the United States Patent and Trademark Office;

WHEREAS, pursuant to the Security Agreement, the Pledgors executed and delivered to the Collateral Agent (i) a Trademark Security Agreement, dated as of July 1, 2020 (the “Second Trademark Security Agreement”) and (ii) a Trademark Security Agreement, dated as of January 24, 2023 (the “Third Trademark Security Agreement”) and, together with the First Trademark Security Agreement, Notice of Succession of Agency and Second Trademark Security Agreement, the “Trademark Security Agreements”), for recordal with the United States Patent and Trademark Office;

WHEREAS, (i) the First Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 22, 2017 at Reel/Frame 6065/0540, (ii) the Notice of Succession of Agency was recorded with the United States Patent and Trademark Office on May 08, 2019 at Reel/Frame 6639/0577, (iii) the Second Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 06, 2020 at Reel/Frame 6990/0977 and (iv) the Third Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 04, 2023 at Reel/Frame 8061/0344;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreements, as applicable.

2. Release. The Collateral Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to all of its right, title and interest in, to and under all of the following Collateral of each Pledgor (collectively, the “Trademark Collateral”):

- (a) Trademarks of such Pledgor listed on Schedule A, attached hereto;
- (b) all goodwill associated with such Trademarks; and
- (c) all Proceeds of any and all of the foregoing.

If and to the extent that the Collateral Agent has acquired any right, title or interest in and to the Trademark Collateral under the Trademark Security Agreements, the Collateral Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to each such Pledgor.

3. Termination. The Collateral Agent, without representation or warranty of any kind, terminates and cancels each of the Trademark Security Agreements.

4. Further Assurances. The Collateral Agent agrees to take all further actions, and provide to the Pledgors and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Pledgors, at the Pledgors' sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Recordation. The Collateral Agent authorizes and requests that the Commissioner of Trademarks and any other applicable government officer record this Release.


6. Execution in Counterparts. This Release may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

7. Governing Law. THIS RELEASE SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK, WITHOUT REGARD TO CONFLICTS OF LAW PRINCIPLES THAT WOULD REQUIRE THE APPLICATION OF THE LAWS OF ANOTHER JURISDICTION, EXCEPT TO THE EXTENT THAT THE UCC PROVIDES THAT PERFECTION OF THE SECURITY INTEREST HEREUNDER, OR REMEDIES HEREUNDER, IN RESPECT OF ANY PARTICULAR COLLATERAL ARE GOVERNED BY THE LAWS OF A JURISDICTION OTHER THAN THE STATE OF NEW YORK, IN WHICH CASE THE LAWS OF SUCH JURISDICTION SHALL GOVERN WITH RESPECT TO THE PERFECTION OF THE SECURITY INTEREST IN, OR THE REMEDIES WITH RESPECT TO, SUCH PARTICULAR COLLATERAL.
