WHEREAS, pursuant to (a) the Intellectual Property Security Agreement, dated as of February 28, 2020 (the “**2020 Security Agreement**”), recorded with (x) the United States Patent and Trademark Office (the “**USPTO**”) at Trademark Reel/Frame 6878/0085 and (y) the United States Copyright Office (the “**USCO**”), The Corridor Group Holdings, LLC, as “Assignor”, assigned to and granted Brightwood Loan Services LLC, as collateral agent (the “**Assignee**”), a security interest in and to the trademarks and copyrights listed on Schedule A hereto (the “**2020 Intellectual Property**”) as well as other trademarks, copyrights and patents and (b) the Intellectual Property Security Agreement, dated as of March 6, 2023 (together with the 2020 Security Agreement, the “**Security Agreements**”), recorded with USPTO at Trademark Reel/Frame 8011/0501, CP Corridor AHC, LLC, as “Assignor”, assigned to and granted the Assignee, a security interest in and to the trademarks and copyrights listed on Schedule B hereto (together with the 2020 Intellectual Property, the “**Intellectual Property**”) as well as other trademarks, copyrights and patents;

WHEREAS, Assignee wishes to provide a document suitable for recording in each of the USPTO and USCO for purposes of recording the termination, release, relinquishment, discharge and cancellation of the Security Agreements and all of its security interest in the Intellectual Property listed on Schedules A and B hereto; and

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Assignee hereby terminates, relinquishes, releases, discharges and cancels the Security Agreements and all of its security interest in the Intellectual Property listed on Schedules A and B hereto, without recourse or representation or warranty, express or implied, of any kind.

1. Further Assurances. The Assignee agrees to take all further actions and provide to each Assignor all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by such Assignor, to more fully and effectively effectuate the purposes of this Release of Intellectual Property Security Interest (this “**Release**”).

2. Counterparts. This Release may be executed in any number of counterparts, all of which taken together shall constitute one agreement, and any of the parties hereto may execute this Release by signing any such counterpart. Each Assignor acknowledges that delivery of an executed counterpart of a signature page of this Release by fax or electronic mail transmission shall be effective as delivery of a manually executed counterpart of this Release.


