Re: Release of Security Interest


Reference is made to the Intellectual Property Security Agreement executed July 23, 2020 (the “**IP Security Agreement**”), in which LGM PHARMA SOLUTIONS, LLC, a Delaware limited liability company (“**Grantor**”), granted to HANCOCK WHITNEY BANK, as administrative agent (“**Administrative Agent**”) for itself and other Secured Parties, a security interest in certain Collateral.
