**TERMINATION AND RELEASE OF  
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “*Termination and Release*”) is granted as of December 1, 2023 by **SILICON VALLEY BANK**, a division of **FIRST-CITIZENS BANK & TRUST COMPANY** (successor by purchase to the Federal Deposit Insurance Corporation as receiver for Silicon Valley Bridge Bank, N.A. (as successor to Silicon Valley Bank (“*SVB*”))), as Administrative Agent (the “*Assignee*”), in favor of **HEALTHTRIO LLC**, a Delaware limited liability company (the “*Grantor*”).

**WHEREAS**, the Grantor executed and delivered an Intellectual Property Security Agreement dated as of January 29, 2021 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*Grant*”) granting to SVB, as predecessor in the interest to the Assignee, a security interest in and lien on certain Intellectual Property Collateral (including without limitation those Copyrights, Patents, and Trademarks listed on Exhibits A, B, and C thereto, respectively), and including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits) and goodwill associated therewith, the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions continuations, renewals, extensions and continuations-in-part thereof, which was recorded with (i) the United States Copyright Office (“*USCO*”) on January 29, 2021, at Volume 15001, Doc. No. 027 with respect to the Intellectual Property Collateral consisting of certain Copyrights or (ii) the United States Patent and Trademark Office (“*USPTO*”) on January 29, 2021, (x) at Reel 7173, Frame 0617 with respect to the Intellectual Property Collateral consisting of certain Trademarks and (y) at Reel 055171, Frame 0563 with respect to the Intellectual Property Collateral consisting of certain Patents, as applicable;

**WHEREAS**, the Grantor has requested that Assignee hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantor in, to and under all Intellectual Property Collateral, including without limitation all of the (x) Copyrights identified in Schedule I hereto, (y) Trademarks identified in Schedule II hereto and (z) Patents identified in Schedule III hereto;

**WHEREAS**, the Grantor has requested that the Assignee provide a document suitable for recording with the USCO to evidence the release of the Assignee’s security interests in and liens on the certain Copyrights as herein provided; and

**WHEREAS**, the Grantor has requested that the Assignee provide a document suitable for recording with the USPTO to evidence the release of the Assignee’s security interests in and liens on the certain Trademarks and Patents as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby:

1. terminates the Grant and releases, terminates and discharges all liens and security interests in the Grantor’s right, title and interest in, to and under all Intellectual Property Collateral including without limitation all Copyrights identified in Schedule I hereto, all

Trademarks identified in Schedule II hereto and all Patents identified in Schedule III hereto; and

2. authorizes and requests that this Termination and Release be recorded at the USCO or the USPTO, as applicable; and
3. re-assigns to the Grantor any right, title or interest that the Assignee may have in the Intellectual Property Collateral identified in Schedule I, Schedule II or Schedule III hereto.<sup>1</sup>

Delivery of an executed counterpart by electronic transmission shall be equally effective as delivery of an original executed counterpart.

THIS TERMINATION AND RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE INTERNAL LAWS (AND NOT THE CONFLICT OF LAW RULES) OF THE STATE OF NEW YORK.
