**TERMINATION AND RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of November 29, 2023 (this "Release"), is made by DEERPATH FUND SERVICES, LLC, a Delaware limited liability company, ("Secured Party") in favor of CDC DENTAL MANAGEMENT CO., LLC, a Delaware limited liability company ("Grantor").

WHEREAS, Grantor has executed and delivered to Secured Party that certain Loan Agreement, dated December 3, 2018 (the "Loan Agreement"); and

WHEREAS, to secure the obligations of Grantor to Secured Party under the Loan Agreement, Grantor and Secured Party entered into, among other things, that certain Patent and Trademark Security Agreement, dated December 3, 2018 (the "Security Agreement"), pursuant to which Grantor granted to Secured Party a continuing security interest in, and a right to set off against, any and all right, title and interest of Grantor in and to all Patent and Trademark Collateral (as defined in the Security Agreement), including, but not limited to, the trademark registrations listed on Schedule A attached hereto.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party and Grantor agree as follows:

SECTION 1. Termination and Release. Secured Party, without representation, warranty, or recourse, express or implied, hereby:

(a) terminates the Security Agreement and terminates, cancels, discharges, and releases any and all security interests in, and the right to set off against, any and all right, title and interest of Grantor in and to the Patent and Trademark Collateral, including, but not limited to, the trademark registrations listed on Schedule A attached hereto, granted pursuant to the Security Agreement and/or Loan Agreement, and hereby reassigns to the Grantor any and all right, title and interest that it may have, in and to the Patent and Trademark Collateral; and

(b) authorizes the recordation of this Release with the United States Patent and Trademark Office at Grantor's expense.


