TRADEMARK PURCHASE AGREEMENT

Sutter Home Winery, Inc. ("Seller") is the owner of U.S. Trademark Registration No. 4632657 for the mark ENTANGLED for "alcoholic beverages except beers" ("ENTANGLED Registration"). Quantum Limit Partners, LLC ("Buyer") wishes to acquire the ENTANGLED Registration from Seller, and Seller wishes to sell the ENTANGLED Registration to Buyer.

Accordingly, Buyer shall provide Seller with a check for \$250.00 made out to Sutter Home Winery, Inc. (the "Check"). Seller shall execute the attached trademark assignment for the ENTANGLED Registration (the "Assignment"). Once the Check has cleared Seller's bank account, Seller will then provide the Assignment to Buyer for recordation with the U.S. Patent and Trademark Office ("USPTO").

In the event there are any problems with the Assignment raised by USPTO, Seller agrees to reasonably cooperate to execute any other documents necessary to effect the assignment of the ENTANGLED Registration.

Seller warrants that it is the owner of the ENTANGLED Registration and it has the power to execute the Assignment, but Seller makes no warranty as to the validity of the ENTANGLED trademark or registration nor does Seller warrant that the ENTANGLED trademark does not infringe any rights belonging to any other parties. Seller agrees not to use the ENTANGLED trademark going forward, that it will not challenge Buyer's rights in the ENTANGLED Registration, and that it will not challenge Buyer's rights in the ENTANGLED mark for so long as the ENTANGLED mark is valid and subsisting.

By signing below, each of the parties acknowledges the above terms of this agreement as between the parties. Within ten days of execution of this agreement, each party shall fulfill its obligations by providing the respective Assignment or Check to the other party.
