Under Section 1003 of the Limited Liability Company Law

1. The name (and, if the name has been changed, the name under which it was formed) and jurisdiction of formation or organization of each limited liability company or other business entity that is to merge is:
 - The Caldwell Manufacturing Company, a New York corporation (the "**Merging Entity**").
 - Caldwell Manufacturing Company North America, LLC, a New York limited liability company (the "**Surviving Company**").
2. For each domestic limited liability company and domestic other business entity, the date when its initial articles of organization or formation document was filed with the Department of State of the State of New York (the "**Department of State**") is:
 - The Merging Entity filed its initial Certificate of Incorporation on January 4, 1910.

4. An agreement of merger has been approved, adopted and executed by each domestic limited liability company or other business entity that is to merge.
5. The effective date of the merger, in accordance with Section 1003(b) of the NY LLC Law, is July 31, 2023.
6. The Secretary of State of the State of New York (the "**Secretary of State**") is designated as the Surviving Company's agent upon whom process against it may be served. The address within or without the State of New York to which the Secretary of State shall mail a copy of any process against the Surviving Company served upon the Secretary of State is 2605 Manitou Road, Rochester, New York 14624.
7. The agreement of merger is on file at the Surviving Company's place of business located at 2605 Manitou Road, Rochester, New York 14624.
8. The Surviving Company will furnish a copy of the agreement of merger upon request and without cost to any member of any domestic limited liability company or any person holding an interest in any other business entity that is to merge pursuant to such agreement.

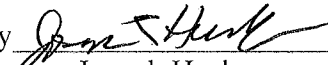
