The undersigned being hereby warned that willful false statements and the like so made are punishable by fine or imprisonment, or both, under 18 U.S.C. 1001, and that such willful false statements may jeopardize the validity of the application, declares that:

1. I am an attorney for Villain Acquisition LLC, the party that filed the subject assignments against the above identified application, and I am properly authorized to execute this declaration.

2. Villain LLC (a California limited liability company) is the proper owner of application Serial No. 97864514 for the mark VILN.

3. The assignment dated July 31, 2023 and recorded on August 8, 2023 at **Reel/Frame 8159/0556** assigning trademark application Serial No. 97864514 from Villain LLC (a New York limited liability company) to Villain Acquisition LLC (a New York limited liability company) was incorrectly filed. The subject application is actually owned by Villain LLC (a California limited liability company), which is a separate, distinct, and unrelated entity to Villain LLC (a New York limited liability company). As such, the recordation of the assignment was improper.

4. Villain Acquisition LLC also entered into a trademark security agreement against the subject application on July 31, 2023 in favor of Wilmington Trust, National Association. Said trademark security agreement was recorded on July 31, 2023 at **Reel/Frame 8150/0151**. However, as noted above, Villain Acquisition LLC did not properly own the subject application, which was owned by a California entity having the same name as the New York entity that inadvertently assigned the application to Villain Acquisition LLC.

5. Villain LLC (a New York limited liability company) and Villain Acquisition LLC (a New York limited liability company) have never had any right, title or interest in application Serial No. 97864514 for the mark VILN.

6. Thus, the chain of title for application Serial No. 97864514 should not be considered altered by the improper assignments recorded at **Reel/Frame 8159/0556** and **Reel/Frame 8150/0151**, and the original applicant, Villain LLC (a California limited liability company) continues to be the true and correct owner of the application.

All the foregoing statements are made of my own knowledge and are true.
