I, ERIC T. FINGERHUT, hereby declare and state as follows:

1. I am an active member of the bar of the District of Columbia and an attorney with the law firm of Dykema Gossett PLLC. I am counsel of record for Commonwealth Brands, LLC. I have personal knowledge of the matters set forth herein and if I am called upon to testify, I could and would testify competently thereto. This declaration is submitted in support of a Correction by Declaration to remove the Entity Conversion recorded as Assignment: 3 against United States Registration No. 3488536 of the mark BALI SHAG.

2. On December 7, 2022, I prepared a Trademark Assignment Coversheet identifying eleven (11) registrations or applications affected by the Entity Conversion. The Entity Conversion was from Commonwealth Brands, Inc to Commonwealth Brands, LLC. In the Trademark Assignment Coversheet, I mistakenly listed United States Registration No. 3488536 of the mark BALI SHAG as one of the properties covered by the Entity Conversion. This was a mistake as Registration No. 3488536 was and is still owned by Top Tobacco L.P., not Commonwealth

Brands, Inc. (or LLC). The Entity Conversion was recorded against U.S. Registration No. 3488536, among others, on December 7, 2022, at Reel: 007909/Frame: 0393.

3. I hereby request that the Entity Conversion recorded at Reel: 007909/Frame: 0393 be removed from Assignment History of U.S. Registration No. 3488536 of the mark BALI SHAG so that Top Tobacco L.P. is once again correctly listed as its owner in the publicly accessible records of the United States Patent and Trademark Office.

I declare, being hereby warned that willful false statements and the like so made are punishable by fine or imprisonment, or both, under 18 U.S.C. §1001, that all statements made herein on personal knowledge are true, and all statements made on information are believed to be true.

Article I: The name of the limited liability company is Commonwealth Brands, LLC.

Article III: The mailing address of the limited liability company's initial principal office is 714 Green Valley Road, Greensboro, North Carolina 27408.

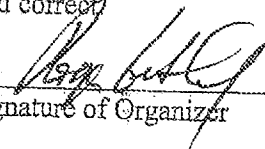
Article IV: The limited liability company is to be managed by its member(s).
