**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE dated as of April 30, 2015, from JPMORGAN CHASE BANK, N.A., as Collateral Agent (the "Agent") for the Secured Parties, to AMERICAN BEACON ADVISORS, INC., a Delaware corporation, located at 4151 Amon Carter Blvd., MD 2450, Fort Worth, TX 76155 (the "Borrower") and AMERICAN PRIVATE EQUITY MANAGEMENT, L.L.C., a Delaware limited liability company, located at 4151 Amon Carter Blvd., MD 2450, Fort Worth, TX 76155 ("APEM" and collectively with the Borrower, "Grantors").

WITNESSETH:

WHEREAS, pursuant to the Pledge and Security Agreement, dated as of November 22, 2013, made by the Grantors in favor of the Agent (the "Pledge and Security Agreement"), a security interest (the "Security Interest") was granted by the Grantors to the Agent in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of November 22, 2013, between the Agent and Grantors (the "Trademark Security Agreement"), Grantors, by reference to the Pledge and Security Agreement, reaffirmed its intent to grant a Security Interest to the Agent specifically in certain Trademark Collateral;

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on November 22, 2013 at Reel 5159 and Frame 0804 and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Pledge and Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:


1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Grantors' right, title and interest in, to and under the Trademarks of the Grantors listed on Schedule A attached hereto and all goodwill associated with such Trademarks. The term "Trademarks" shall have the meaning provided by reference in the Pledge and Security Agreement and the Trademark Security Agreement.

2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void.

3. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
