RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST ("**Release**") is made and effective as of November 30, 2023, and granted by Rosenthal & Rosenthal of California, Inc. (the "**Secured Party**") and its successors, assigns and legal representatives.

WHEREAS, pursuant any and all loan agreements and documents by and between Naturium LLC (the "**Debtor**") and Secured Party (the "**Loan Documents**"), including the Security Interest executed by Debtor dated August 8, 2022 (the "**Trademark Security Agreement**");

WHEREAS, pursuant to the Loan Documents, the Debtor pledged and granted to the Secured Party a security interest in and to all of the right, title and interest of such Debtor in, to and under the Trademark Collateral (as defined below);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 007851, Frame 0346 on September 21, 2022; and

WHEREAS, the Debtor has requested that the Secured Party enter into this Release in order to effectuate, evidence and record the release and reassignment to the Debtor (without any recourse, representation or warranty of any kind by Secured Party) of any and all right, title and interest the Secured Party may have in the Trademark Collateral pursuant to the Loan Documents.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby states as follows:

1. Release of Security Interest. Secured Party, its successors, legal representatives and assigns, hereby terminates the Trademark Security Agreement and terminates, releases and discharges any and all security interests that it has pursuant to the Loan Documents in any and all right, title and interest of the Debtor, and reassigns to the Debtor any and all right, title and interest that it may have, in, to and under the following (collectively, the "**Trademark Collateral**");

(a) any and all trademarks, trademark applications and other patent rights and any other governmental authority-issued indicia of trademark or brand ownership, including the trademarks listed in Schedule 1 hereto (the "**Trademarks**");

(b) all rights of any kind whatsoever of such Secured Party accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;

(c) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(d) any and all claims and causes of action, with respect to any of the foregoing, whether occurring before, on or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.



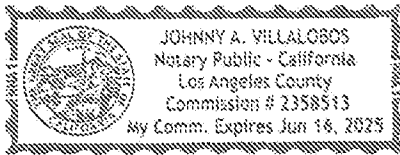
