TERMINATION OF
TRADEMARK SECURITY AGREEMENT

This TERMINATION OF TRADEMARK SECURITY AGREEMENT dated as of November 29, 2023 (this "Termination"), is made by Comerica Bank, as administrative agent (in such capacity, together with any successors and assigns in such capacity, the "Administrative Agent"), in favor of Park County, LLC and the other Credit Parties referred to in the Credit Agreement (as defined below) (collectively, the "Grantors," and individually, each a "Grantor") from time to time party to the Trademark Security Agreement (as defined below).

WHEREAS, the Grantors, the Administrative Agent and the other parties thereto entered into that certain First Amended and Restated Credit, Security, Guaranty and Pledge Agreement dated as of May 28, 2021 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement");

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of August 30, 2019 (as amended, restated, supplemented, or otherwise modified from time to time, the "Trademark Security Agreement"; capitalized terms used herein without definition shall have the meanings ascribed thereto in the Trademark Security Agreement), by and among the Grantors and the Administrative Agent, each Grantor granted to the Administrative Agent (for the benefit of the Secured Parties) a continuing security interest (the "Security Interest") in the Trademark Collateral of such Grantor;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on September 3, 2019, at Reel 6735, Frame 0283; and

WHEREAS, the Administrative Agent has agreed to terminate the Trademark Security Agreement and release its Security Interest in each Grantor's Trademark Collateral, including, without limitation, the Trademarks identified on Schedule A attached hereto.

NOW, THEREFORE, for valuable consideration, the Administrative Agent hereby (i) terminates the Trademark Security Agreement, (ii) discharges, cancels and fully and unconditionally releases the collateral pledge, grant, mortgages, liens, collateral assignments, Security Interest, and all right, title and interest in, to, and under the Trademark Collateral, including, without limitation, those Trademarks identified on Schedule A hereto, (iii) without recourse, representation or warranty, reassigns, transfers, sets over and reconveys to each Grantor all of such Grantor's right, title and interest in and to the Collateral subject to said Trademark Security Agreement and (iv) authorizes each Grantor to record this Termination with the United States Patent and Trademark Office.

This Termination is governed by the laws of the State of New York.
