TRADEMARK ASSIGNMENT

This Trademark Assignment (the “Trademark Assignment”) is made this 7th day of December, 2023 by and between Norwalk Compressor Company, a Connecticut corporation with a place of business located at 1650 Stratford Avenue, Stratford, Connecticut 06615, United States (hereinafter “ASSIGNOR”) and Neuman & Esser Investments, Inc., a Delaware corporation having a place of business located at 1502 East Summitry Circle, Katy, Texas 77449, United States (hereinafter “ASSIGNEE”).

WHEREAS, ASSIGNEE is desirous of acquiring the entire right, title and interest in U.S. Trademark Registration No. 4550998 (hereinafter “Registration”), registered on June 17, 2014 for the mark “NORWALK” in stylized form (hereinafter “Mark”) and to any and all common law rights to the Mark throughout the world.

WHEREAS, ASSIGNOR desires to sell, assign, and transfer to ASSIGNEE all rights within the United States in and to the Registration and all rights throughout the world in and to the Mark, owned by ASSIGNOR for such Registration and Mark, and the goodwill associated therewith;

NOW, THEREFORE, on the basis of mutual covenants made between the parties and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. ASSIGNOR does hereby sell, assign, and transfer to ASSIGNEE, its successors and assigns, the entire right, title and interest in and to the Registration within the United States, and to the Mark including any and all common law rights to the Mark throughout the world, together with the goodwill associated with the Registration and Mark and the business to which the Registration and Mark pertain, as well as the rights to sue, recover and retain damages for any


past, current, or future infringements of the Registration and Mark, the right to use the Registration and Mark in advertising, and the rights to sell and license the Registration and Mark.

2. ASSIGNOR agrees to cooperate with ASSIGNEE and to perform all acts and to execute all documents that may reasonably be required by the appropriate governing authority to effectuate fully and implement the assignment and/or maintain the Registration and Mark pursuant to this Trademark Assignment.

3. This Trademark Assignment shall be governed and interpreted according to the laws of the State of Texas.
