**RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY**

THIS RELEASE OF SECURITY AGREEMENT IN INTELLECTUAL PROPERTY (this "Release") dated as of the 30th day of November, 2023, is executed by JPMORGAN CHASE BANK, N.A., as successor to NBD Bank ("Lender").

RECITALS

A. On or about July 27, 1995, NBD Bank, an Illinois banking corporation and Demert & Dougherty, Inc., an Illinois corporation, a predecessor of Gold Eagle Co. ("Grantor"), executed a certain Trademark Collateral Assignment and Security Agreement (the "IP Security Agreement") in favor of Lender and recorded with the U.S. Patent and Trademark Office on August 14, 1995, at Reel No. 001355, Frame No. 0509 through 0525, pursuant to which the Grantor conveyed to the Lender a security interest in and to certain intellectual property of the Grantor (such intellectual property, the "Intellectual Property").

B. In connection with certain transactions, the Lender has agreed to terminate its security interest in certain trademarks of the Grantor which were part of the Intellectual Property pledged to the Lender under the IP Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the parties hereby agree as follows:


1. Release of Security Interest in Certain Trademarks. The IP Security Agreement is hereby terminated. Further, the Lender, hereby terminates, cancels and releases its security interest in and to the Intellectual Property.
2. Authorization. The Lender hereby authorizes the Grantor (or its designee), at the expense of the Grantor, to file this Release in the applicable filing and recording offices to effect a release of the specified Intellectual Property.
3. Governing Law. This Release will be governed by and construed in accordance with the laws of the State of Illinois, applicable to contracts to be made and wholly performed within such state, and applicable federal law.
