TRADEMARK ASSIGNMENT

This Trademark Assignment ("Assignment") is made and entered into effective the 29th day of August, 2023 (the "Effective Date") by and between General Electric Company, a New York corporation, having an address at 1 River Road, Schenectady, New York 12305 ("Assignor"), and GE Infrastructure Technology LLC ("Assignee").

WHEREAS, Assignor owns the entire rights, title and interest in and to the trademarks and related registrations and applications listed on Schedule 1 attached hereto ("Trademark Property");

WHEREAS, Assignee desires to acquire any and all of Assignor's rights, title and interest in and to the Trademark Property together with all the goodwill of the business associated therewith, and Assignor desires to transfer any and all such rights, title and interest in and to the Trademark Property, upon the term and conditions set forth herein;

NOW THEREFORE, for good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, and in consideration of the mutual promises, covenants, representations, warranties and obligations set forth in this Assignment, Assignor and Assignee agree as follows:

1. Assignor hereby irrevocably assigns, transfers and otherwise conveys to Assignee all rights, title, and interest in and to the Trademark Property throughout the world, together with the goodwill associated therewith, and including all registrations, pending applications, renewals and extensions of the foregoing, common law rights therein, and all rights of action, powers and benefit to the Trademark Property, due or accrued, including: (a) the right to sue for and recover in the Assignee's own name and that of its successors and assigns and other legal representatives, all remedies of every nature, including without limitation, rights to injunctive relief, damages, profits, costs and attorney fees, arising out of any past, present or future infringement of the Trademark Property, including the right to collect damages for past infringement; (b) the right to register, prosecute, maintain and defend the Trademark Property; and (c) the right to fully stand in the place of Assignor in all matters related thereto.



Notwithstanding anything to the contrary contained herein, the Trademark Property shall not include any application for registration of a trademark that would be invalidated, canceled, voided or abandoned due to the conveyance, assignment and/or transfer of the Trademark Property hereunder, including intent-to-use applications filed with the United States Patent and Trademark Office ("USPTO") pursuant to 15 USC Section 1051(b) prior to the filing and acceptance of a statement of use or amendment to allege use pursuant to 15 USC 1051(c) or (d), in each case, solely to the extent and solely until such time that the conveyance, assignment and/or transfer of the Trademark Property hereunder will not cause such trademark to be invalidated, canceled, voided or abandoned.

2. Assignor hereby requests and authorizes the Commissioner for Trademarks in the USPTO and any other applicable governmental authority or registrar (including any applicable foreign or international office or registrar), to record and register the Assignee as the owner of the Trademark Property, and to issue any and all registrations for the Trademark Property to the Assignee.
3. This Assignment may be executed in one or more counterparts, each of which will be deemed an original and all of which, when taken together, will constitute one and the same assignment.



4. This Agreement shall be governed and construed in all respects by the laws of the State of New York, without reference to its conflicts of law principles.
