## **CONFIRMATORY TRADEMARK ASSIGNMENT**

**THIS TRADEMARK ASSIGNMENT**, having an effective date of October 4, 2022, is made by and between Bayer Aktiengesellschaft, a German company, having an address at Kaiser-Wilhelm-Allee 1, Leverkusen, Germany 51373 ("Assignor") and Discovery Purchaser Corporation, a Delaware corporation, having an address at Tower 49, 12 East 49th Street, New York, NY 10017, United States of America ("Assignee").

**WHEREAS**, Assignor and Assignee are among the parties to that certain Share and Asset Purchase Agreement, dated as of March 7, 2022 (as amended, supplemented or modified, the "Purchase Agreement");

**WHEREAS**, pursuant to the Purchase Agreement, Assignor sold, conveyed, assigned, and transferred to Assignee all right, title, and interest in and to the trademark registrations set forth on Schedule A and all common law and other rights, worldwide, in and to the trademark that are the subject of such registration (such rights, collectively, the "Trademarks"); and

**WHEREAS**, pursuant to the Trademark Assignment Agreement and Back-License Agreement, dated October 4, 2022 (the "Assignment Agreement"), between Assignor and Assignee, Assignor assigned to Assignee all right, title, and interest in and to the Trademarks including any rights to the Trademarks; and

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignor hereby sells, grants, assigns, transfers, and delivers to Assignee all of its rights, title and interests in and to the Trademark, including without limitation the goodwill of the business appurtenant thereto and which is symbolized thereby, and the right to renew any registration therefor, to be held and enjoyed by Assignee for its own use and benefit and for the use and benefit of its successors, assigns and legal representatives, to be used as fully and entirely as said rights would have been held and enjoyed by Assignor had this assignment and sale not been made, together with all claims for damage by reason of past, present or future infringement of said Trademark with the right to sue and collect the same for its own use or for the use of its successors, assigns or other legal representatives.
3. This Trademark Assignment may be executed simultaneously in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
4. Assignor hereby requests the Commissioner of Patents and Trademarks, and the corresponding entities or agencies in any applicable foreign countries, to record Assignee as the assignee and owner of the Trademarks.
