## RELEASE OF SECURITY INTEREST

This RELEASE OF SECURITY INTEREST (the "Release"), effective as of December 12, 2023, is made by and between among On Location, Inc., a New Jersey corporation ("On Location"), and The Peninsula Fund V Limited Partnership, a Delaware limited partnership (hereinafter "Peninsula"), each of the foregoing being individually a "Party" and collectively, the "Parties."

WHEREAS, On Location and Peninsula entered into a Note Purchase Agreement dated February 25, 2015 (the "Note Agreement") for certain extensions of credit by Peninsula to On Location;

WHEREAS, in connection with the terms of the Note Agreement, On Location delivered to Peninsula that certain Security Agreement dated February 25, 2015 whereby On Location granted to Peninsula a security interest ("Security Interest") in the trademarks listed on the attached Schedule A attached hereto (the "Marks"); and

WHEREAS, On Location has satisfied its obligations to Peninsula under the Note Agreement so it is appropriate for the Security Interest in the Marks to be released.

NOW, THEREFORE, in consideration of the promises, representations, warranties and mutual covenants of the Parties, and upon the terms set forth herein, the Parties intending to be legally bound, agree as follows:

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Peninsula, hereby releases and fully discharges the Security Interest and any other right or right of control granted in the Security Agreement or Note Agreement in relation to the Marks. To the extent that Peninsula has any remaining right or interest in any Mark, Peninsula hereby assigns and agrees to assign such remaining right or interest to On Location. Peninsula will cooperate with On Location, at the sole cost and expense of On Location, including performance of any actions, and the execution and delivery of any documents necessary or appropriate to give effect to the intent and terms of this Release and allow On Location to effectively record it with any appropriate government offices.
