## INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (this “Assignment”), including all schedules attached hereto, is made as of this 3rd day of December, 2023 by Vi-Jon, LLC, a Delaware limited liability company, with a business address of 8800 Page Avenue, St. Louis, MO 63114 (“Vi-Jon”), Vivos Holdings, LLC, a Delaware limited liability company, with a business address of 8800 Page Avenue, St. Louis, MO 63114 (“Vivos”), Consumer Product Partners, LLC, a Delaware limited liability company, with a business address of 8800 Page Avenue, St. Louis, MO 63114 (“CPP”) and Uplift Brands, LLC, a Delaware limited liability company, with a business address of 8800 Page Avenue, St. Louis, MO 63114 (“Uplift”). Vi-Jon, Vivos, CPP and Uplift may be referred to in this Assignment each as a “Party” and collectively as the “Parties.”

In consideration of the execution of the Contribution Agreements (as defined below), the mutual promises and covenants hereinafter set forth, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound thereby, the Parties agree as follows:

1. Reference is hereby made to the following:

1.1 Vi-Jon and Vivos entered into that certain Contribution Agreement dated December 3, 2023 (the “Vi-Jon to Vivos Contribution Agreement”), pursuant to which Vi-Jon agreed to transfer to Vivos the patents and patent applications and the trademarks and applications and registrations therefor, as set forth on Schedule A attached hereto (collectively, the “Vi-Jon to Vivos Assigned Patents and Trademarks”), as successor to the business of Vi-Jon to which the trademarks included in the Vi-Jon to Vivos Assigned Patents and Trademarks pertain, which business is ongoing and existing.

1.2 Vivos and CPP entered into that certain Contribution Agreement dated December 3, 2023 (the “Vivos to CPP Contribution Agreement”), pursuant to which Vivos agreed to transfer to CPP a portion of the Vi-Jon to Vivos Assigned Patents and Trademarks, as set forth on Schedule B attached hereto (collectively, the “Vivos to CPP Assigned Patents and Trademarks”), as successor to the business of Vivos to which the trademarks included in the Vivos to CPP Assigned Patents and Trademarks pertain, which business is ongoing and existing.

1.3 Vivos and Uplift entered into that certain Contribution Agreement dated December 3, 2023 (the “Vivos to Uplift Contribution Agreement”), pursuant to which Vivos agreed to transfer to Uplift a portion of the Vi-Jon to Vivos Assigned Patents and Trademarks, as set forth on Schedule C attached hereto (collectively, the “Vivos to Uplift Assigned Patents and Trademarks”), as successor to the business of Vivos to which the trademarks included in the Vivos to Uplift Assigned Patents and Trademarks pertain, which business is ongoing and existing.

1.4 “Contribution Agreements” means the Vi-Jon to Vivos Contribution Agreement, Vivos to CPP Contribution Agreement and the Vivos to Uplift Contribution Agreement.

2. Subject to the terms and conditions of the Vi-Jon to Vivos Contribution Agreement, Vi-Jon hereby contributes, transfers, and assigns to Vivos, and Vivos hereby accepts the contribution, transfer and assignment of, all of Vi-Jon’s worldwide right, title and interest in, to

and under the Vi-Jon to Vivos Assigned Patents and Trademarks, all associated goodwill, and all rights to sue for infringement of any Vi-Jon to Vivos Assigned Patents and Trademarks, the same to be held and enjoyed by Vivos, its successors and assigns from and after the date hereof as fully and entirely as the same would have been held and enjoyed by Vi-Jon had this assignment not been made.

3. Effective immediately after its receipt of the Vi-Jon to Vivos Assigned Patents and Trademarks, then: (i) subject to the terms and conditions of the Vivos to CPP Contribution Agreement, Vivos hereby contributes, transfers, and assigns to CPP, and CPP hereby accepts the contribution, transfer and assignment of, all of Vivos' worldwide right, title and interest in, to and under the Vivos to CPP Assigned Patents and Trademarks, all associated goodwill, and all rights to sue for infringement of any Vivos to CPP Assigned Patents and Trademarks, the same to be held and enjoyed by CPP, its successors and assigns from and after the date hereof as fully and entirely as the same would have been held and enjoyed by Vivos had this assignment not been made and (ii) subject to the terms and conditions of the Vivos to Uplift Contribution Agreement, Vivos hereby contributes, transfers, and assigns to Uplift, and Uplift hereby accepts the contribution, transfer and assignment of, all of Vivos' worldwide right, title and interest in, to and under the Vivos to Uplift Assigned Patents and Trademarks, all associated goodwill, and all rights to sue for infringement of any Vivos to Uplift Assigned Patents and Trademarks, the same to be held and enjoyed by Uplift, its successors and assigns from and after the date hereof as fully and entirely as the same would have been held and enjoyed by Vivos had this assignment not been made.

4. Each of Vivos, CPP and Uplift may record this Assignment with the United States Patent and Trademark Office and with comparable offices in other jurisdictions throughout the world, as may be necessary or appropriate, in respect of the patents, patent applications and trademark registrations and pending applications therefor that are assigned to such Party under this Assignment, and Vi-Jon and Vivos, as applicable will cooperate in executing documents requested by each Party to which patents, patent applications and trademark registrations and pending applications therefor are assigned under this Assignment to complete formalities for recordation of the assignment of such registrations and pending applications with the appropriate governmental authorities. All costs associated with any such registrations or recordations shall be paid by party to which such assignment was made.

5. Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Assignment shall be governed by and construed in accordance with the laws of the State of Delaware without regard to the principles of conflicts of laws thereunder.




