SUPPLEMENTAL TRADEMARK SECURITY AGREEMENT

THIS SUPPLEMENTAL TRADEMARK SECURITY AGREEMENT, dated as of December 8, 2023 (this "Agreement"), by each of the signatories designated as a Grantor on the signature pages hereto (together with any other entity that may become a party hereto as a Grantor as provided herein (each, a "Grantor" and collectively, the "Grantors")), in favor of BANK OF MONTREAL, in its capacity as administrative agent pursuant to the Credit Agreement (as defined in the U.S. Security Agreement, defined below) (in such capacity, the "Administrative Agent"), for the benefit of the Secured Parties.

WITNESSETH:

WHEREAS, the Grantors are parties to a U.S. Security Agreement, dated as of June 11, 2021 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "U.S. Security Agreement") in favor of the Administrative Agent for the ratable benefit of the Secured Parties, pursuant to which the Grantors are required to execute and deliver this Agreement;

WHEREAS, the Grantors, in-part, executed that certain Trademark Security Agreement, dated as of June 11, 2021.

NOW, THEREFORE, in consideration of the premises and to induce the Administrative Agent, for the benefit of the Secured Parties, to enter into the Credit Agreement, the Grantors hereby agree with the Administrative Agent as follows:

SECTION 1. Defined Terms. Unless otherwise defined herein, terms defined in the U.S. Security Agreement and used herein have the meaning given to them in the Credit Agreement or the U.S. Security Agreement.

SECTION 2. Grant of Security Interest. The Grantors hereby grants to the Administrative Agent, for the ratable benefit of the Secured Parties, a security interest in and continuing Lien on, all of its right, title and interest in the following Collateral (excluding any Excluded Assets) of the Grantors: all Trademarks of the Grantors, including without limitation, those Trademarks listed on Schedule I attached hereto, together with the goodwill related to the same.

SECTION 3. The Security Agreement. The security interest granted pursuant to this Agreement is granted in conjunction with the security interest granted to the Administrative Agent, for the benefit of the Secured Parties, pursuant to the U.S. Security Agreement and the Grantors hereby acknowledge and affirm that the rights and remedies of the Administrative Agent with respect to the security interest in the Trademarks made and granted hereby and thereby are more fully set forth in the U.S. Security Agreement, the terms of which are incorporated herein by reference. In the event that any provision of this Agreement is deemed to conflict with the U.S. Security Agreement, the provisions of the U.S. Security Agreement shall control.

SECTION 4. Termination. Upon the Termination Date, the Administrative Agent shall, at the expense of the Grantors, execute, acknowledge, and deliver to the Grantors an instrument in writing in recordable form releasing the lien on and security interest in the Trademarks under this Agreement.

SECTION 5. Counterparts. This Agreement may be executed in any number of counterparts, all of which shall constitute one and the same instrument, and any party hereto may execute this Agreement by signing and delivering one or more counterparts.


SECTION 6. Governing Law. THIS TRADEMARK AGREEMENT AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS TRADEMARK AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.

SECTION 7. Submission to Jurisdiction. Each Party hereto hereby irrevocably and unconditionally submits for itself and its property in any legal action or proceeding relating to this Agreement, or for recognition and enforcement of any judgment in respect thereof, to the exclusive general jurisdiction of the courts of the State of New York, the courts of the United States of America for the Southern District of New York, and appellate courts from any thereof.






