NOTICE OF OPTION TO ACQUIRE TRADEMARK

Otis Williams, an individual and U.S. citizen, with an address of Boulevard Management, 21731 Ventura Blvd., Suite 300 Woodland Hills, CA 91364 ("Dr. Williams"), and UMG Recordings, Inc., a Delaware corporation with an address of 2220 Colorado Avenue, Santa Monica, CA 90404 ("UMG," and, together with Dr. Williams, the "Parties") hereby give notice that:

1. The Parties have contemporaneously entered into an agreement (the "Agreement") that (1) conveys, transfers, assigns and delivers to Dr. Williams any and all right, title and interest UMG may have in or to U.S. Registration Nos. 879695 and 3104067, E.U. Registration No. 004540175, and U.K. Registration No. UK00904540175 (collectively, the "Registrations") as well as any trademark or service mark reflected therein, all combinations and variations thereof, all logos associated therewith, together with all goodwill associated with all of the foregoing (collectively, the "Marks"); and (2) licenses-back certain rights in the Marks to UMG.

2. The Agreement grants UMG the right to acquire the Marks (including all applications and registrations therefor) and certain related assets upon certain events identified in the Agreement and payment to Dr. Williams, as more fully set forth therein.

3. UMG fully intends to exercise such option. Such option shall be presumed to be in full force and effect unless the Parties subsequently record an assignment to UMG or a relinquishment of UMG's option to acquire the Marks, either of which shall be signed by both Parties.

4. During the Term (as defined in the Agreement), certain transfers, conveyances, and/or assignments of any right, title and/or interest in and to the Marks may be subject to additional obligations of the Parties under the Agreement, which if not satisfied, may render such attempted transfers, conveyances and/or assignments null and void.

5. Nothing herein shall be construed as a present transfer of the marks to UMG, and the Marks and all applications and registrations therefor shall be held in the name of Dr. Williams.

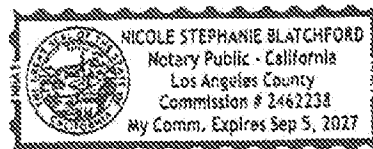
