NUNC PRO TUNC TRADEMARK ASSIGNMENT

This Assignment ("Assignment") is made effective as of December 31, 2022 ("Effective Date") from **JN Projects, Inc.** ("ASSIGNOR"), a Delaware corporation with a principal place of business at 301 Howard Street, Suite 200, San Francisco, California 94105, United States, to **Dropbox, Inc.** ("ASSIGNEE"), a Delaware corporation with a principal place of business at 1800 Owens Street, San Francisco, California 94158, United States.



NOW, THEREFORE, in consideration of the payment of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby conveys, transfers, assigns, delivers, and contributes to ASSIGNEE, *nunc pro tunc* as of December 31, 2022, all of ASSIGNOR'S right, title, and interest of whatever kind in and to the Marks, together with (1) the goodwill of the business relating to the Products in respect upon which the Marks are used and for which they are registered: (2) all income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to the Marks, including without limitation, damages, and payments for past or future infringements and misappropriations of the Marks: and (3) all rights to sue for past, present and future infringements or misappropriations of the Marks.

ASSIGNOR further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing, or vesting in ASSIGNEE full right, title, and interest in the Marks.
