## TRADEMARK AGREEMENT AND ASSIGNMENT

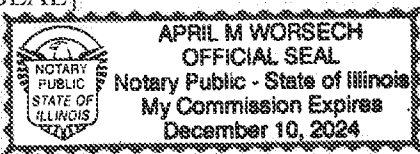

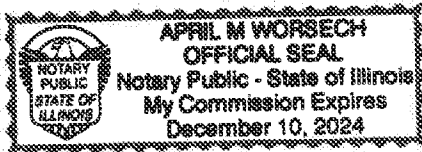
