RELEASE OF TRADEMARK SECURITY INTEREST

This Release of Trademark Security Interest (this "Release") is made as of August 25, 2023, by **CITIZENS BANK, N.A.**, as Administrative Agent for the Secured Parties ("Citizens"), for the benefit of **CLEARSPAN LLC**, a Delaware limited liability company ("Clearspan"). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement (defined below).

W I T N E S S E T H:

WHEREAS, Clearspan and Citizens are parties to that certain (i) Security Agreement, dated as of July 14, 2020 (as amended, restated or otherwise modified through the date hereof, the "Security Agreement") and (ii) Notice of Grant of Security Interest in Trademarks, dated as of July 14, 2020 (the "Trademark Security Interest Notice"), pursuant to which Clearspan has granted to Citizens a lien on and security interest in all of the right, title and interest of Clearspan in, to and under the Trademarks, including the trademarks set forth on Schedule I hereto;

WHEREAS, the Trademark Security Interest Notice was recorded in the United States Patent and Trademark Office (the "USPTO") on July 15, 2020 at Reel 6998 and Frame 0916; and

WHEREAS, Clearspan has requested that Citizens release, and Citizens is willing to release its lien on and security interest in, and any other right, title, and interest it may have in, to and under the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Citizens hereby agrees as follows:

1. Citizens does hereby irrevocably (x) terminate, release and discharge the entirety of any and all liens or security interests that it may have in or to the Trademarks, and all claims, whether presently existing or hereafter acquired or created, pursuant to the Security Agreement or Trademark Security Interest Notice in or to the Trademarks, and any right, title or interest of Citizens in such Trademarks shall hereby terminate, cease and become void and (y) terminate and cancel the Trademark Security Interest Notice. If and to the extent Citizens has acquired any right, title or interest in and to any of the Trademarks, Citizens hereby assigns, transfers and conveys any and all right, title and interest of Citizens in the Trademarks to Clearspan. Citizens authorizes Clearspan or Clearspan's authorized representative or designee to record this Release with the USPTO as evidence of such release and termination.



3. This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York.
