## RELEASE OF PLAIN ENGLISH INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS RELEASE OF PLAIN ENGLISH INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of November 17, 2023, (this “Release”) is made by TRIPLEPOINT VENTURE GROWTH BDC CORP. (“TriplePoint”) under the Plain English Intellectual Property Security Agreement (as amended, supplemented or modified and in effect from time to time, the “Intellectual Property Security Agreement”), between BLUEVINE INC. (formerly BLUEVINE CAPITAL INC.), a Delaware corporation, (the “Bluevine”) and TriplePoint. Capitalized terms used but not defined herein have the meanings provided in the Intellectual Property Security Agreement.

WHEREAS, pursuant to the Intellectual Property Security Agreement which was recorded at the United States Patent and Trademark Office on September 18, 2017 at Reel 6154 and Frame 0769, Bluevine granted to the TriplePoint a continuing security interest in all of Bluevine’s right, title and interest in Intellectual Property (all of the following items of property collectively will be referred to as the “Intellectual Property Collateral”), including:


- all Patents, Patent Licenses, and Patent applications, including specifically those listed on the attached schedule A, together with any reissues, divisions, continuations, renewals, extensions and continuations thereof;
- all Trademarks, Trademark Licenses, and Trademark applications, together with the goodwill of the business symbolized by Bluevine’s Trademarks, including specifically those listed on the attached Schedule B together with any renewals thereof;
- all Copyrights, Copyright Licenses, and applications for Copyrights, including specifically those listed on the attached Schedule C;
- the right to sue for past, present and future infringements of the foregoing and all rights corresponding thereto throughout the world and all re-issues, divisions, continuations, renewals, extensions, and continuation-in-part thereof; and
- all Proceeds.

WHEREAS, Bluevine has requested and TriplePoint has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Intellectual Property Collateral (the “Released Collateral”).

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, TriplePoint does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Intellectual Property Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to TriplePoint in the Released Collateral, and (d) reassigns, grants and conveys to Bluevine any and all right, title and interest it has in the Released Collateral.
