## TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT, dated as of November 1, 2023, is entered into by INDUSTRIAL AIR, LLC, a North Carolina limited liability company (the “*Debtor*”), in favor of Wheaton Bank & Trust Company, N.A., a Subsidiary of Wintrust Financial Corporation, in its capacity as administrative agent for itself and the other Secured Creditors (in such capacity, together with its successors and assigns, the “*Administrative Agent*”).

### WITNESSETH:

WHEREAS, the Debtor is party to a Security Agreement dated as of February 24, 2021 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “*Security Agreement*”), in favor of the Administrative Agent pursuant to which the Debtor is required to execute and deliver this Trademark Security Agreement;

WHEREAS, pursuant to the Security Agreement, the Debtor has granted to the Administrative Agent for the benefit of the Secured Creditors, a continuing security interest in all right, title and interest of the Debtor in, to all Intellectual Property included in the Collateral to secure the payment, performance and observance of the Secured Obligations.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Debtor does hereby grant to the Administrative Agent and grant to the Administrative Agent for the benefit of the Secured Creditors, a continuing security interest in the Trademark Collateral (as defined below).

SECTION 1. Defined Terms. Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement.

SECTION 2. Grant of Security Interest in Trademark Collateral. The Debtor hereby pledges and grants to the Administrative Agent for the benefit of the Secured Parties a lien on and security interest in on all of its right, title and interest in, to and under the Trademarks listed on Schedule I attached hereto, as well as all goodwill connected with the use thereof and symbolized thereby (collectively, the “*Trademark Collateral*”).

SECTION 3. Security Agreement. The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Administrative Agent pursuant to the Security Agreement and the Debtor hereby acknowledges and affirms that the rights and remedies of the Administrative Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Trademark Security Agreement is deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall control.

SECTION 4. Counterparts. This Trademark Security Agreement may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart by facsimile or electronic mail shall be equally effective as delivery of an original executed counterpart.


