**TRADEMARK ASSIGNMENT NUNC PRO TUNC**

WHEREAS, iFIT Inc., a corporation of the State of Delaware, having a principle place of business at 1500 South 1000 West, Logan, Utah 84321 (“Assignor”), is the owner of the entire right, title and interest in the trademarks, as reflected by the records of the U.S. Patent and Trademark Office, identified in the U.S. Trademark Registrations and Applications set forth in the attached Schedule A (the “U.S. Trademark Registrations”);

WHEREAS, The Bikini Body Training Company Pty Ltd., a private limited company of Australia, having a principal place of business at Unit 2, 62-66 Glen Osmond Road, Parkside SA 5062, Australia (“Assignee”), desires to secure all right, title and interest in and to the U.S. Trademark Registration, the goodwill of the business symbolized by and associated with the U.S. Trademark Registration thereby, and the right to sue for past infringement thereof; and

WHEREAS, the Assignor having executed an Trade Mark Assignment Deed on November 17, 2023, wherein Assignor agreed to assign to the Assignee all of the Assignor’s right, title and interest in the U.S. Trademark Registrations and the Assignee agreed to accept such assignment;

WHEREAS, at all times up to and including the execution date of the Trade Mark Assignment Deed, it was the intention of both Parties to transfer the goodwill of the business symbolized by and associated with the U.S. Trademark Registrations, even though the executed assignment failed to expressly recite the term “goodwill”;

WHEREAS, the undersigned each held full signatory authority and authorization to assign and receive all right, title, and interest, including any associated goodwill or rights to sue for past infringement in and to any intellectual property of Assignee prior to the Effective Date;

WHEREAS, in order to reconfirm said Assignment to Assignee, do execute this Assignment Nunc Pro Tunc as of the effective date set forth herein.

In consideration of One Dollar (\$1.00) and other good and valuable consideration paid to Assignor by the Assignee, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR DOES HEREBY ASSIGN TO THE ASSIGNEE:

**The entire right, title and interest in and to the U.S. Trademark Registrations, the goodwill of the business symbolized by and associated with the U.S. Trademark Registrations and the right to bring legal action for any trademark that is likely to cause confusion therewith and the right to sue for past infringement and to receive damages therefore.**

Assignor hereby agrees, without further consideration and without expense to it, to sign all lawful papers and to perform all other lawful acts which Assignee may reasonably request of it to make this Assignment fully effective. Assignor further agrees to provide all evidence upon request by Assignee, including any use in commerce (or lack thereof) of any of the Mark identified in schedule A, which would be reasonably required to maintain, renew, or otherwise establish any new filings of the Mark.

This assignment and agreement shall be binding upon our heirs and legal representatives and shall be effective as of November 17, 2023 (the "Effective Date").
