

CONFIRMATORY TRADEMARK ASSIGNMENT

This CONFIRMATORY TRADEMARK ASSIGNMENT (hereinafter this "<u>Assignment</u>") is entered between **Bondi Sands Pty Ltd**, a proprietary company limited by shares organized under the laws of Australia, having a business address of Level 11, 459 Little Collins Street, Melbourne VIC 3000, as trustee for **Bondi Sands Unit Trust** (ABN 64 901 803 315), a unit trust organized under the laws of Australia ("<u>Assignor</u>") and **Kao Kabushiki Kaisha** a/t/a **Kao Corporation**, an entity incorporated in Japan, having a business address of 14-10 Nihonbashi Kayabacho-1-chome, Chuo-ku, Tokyo 103-8210 Japan ("<u>Assignee</u>"). Assignor and Assignee are collectively referred to herein as the "<u>Parties</u>" and individually referred to herein as a "<u>Party</u>." This Confirmatory Trademark Assignment is effective as of November 1, 2023 ("<u>Effective Date</u>"). Capitalized terms that are not defined in this Agreement have the meanings set forth in the Purchase Agreement.

WHEREAS, both Assignor and Assignee are parties to that certain Share and Asset Sale Agreement dated 27 July 2023 (the "Purchase Agreement");

WHEREAS, pursuant to the Purchase Agreement and as the owner of those trademarks listed on the attached Schedule together with all goodwill associated therewith (the "Trademarks"), Assignor agreed to sell, transfer, assign, convey, and deliver to Assignee all Assignor's right, title, and interest in, to, and under the Trademarks, with effect from the Effective Date ("<u>Trademark Assignment</u>"); and

WHEREAS, in furtherance of the Purchase Agreement and as a party to the Trademark Assignment, Assignee agreed to purchase, acquire and accept from Assignor and did purchase, acquire, and accept from Assignor, all of the Assignor's right, title and interest in, to, and under the Trademarks, with effect from the Effective Date;

NOW, THEREFORE, the Parties hereby confirm:

- 1. That pursuant to the Trademark Assignment executed by the Parties, the Assignor did for good and valuable consideration the receipt and sufficiency of which were acknowledged and are hereby confirmed the Assignor sold, transferred, assigned, conveyed, and delivered to the Assignee and by this instrument does sell, transfer, assign, convey, and deliver to the Assignee, and the Assignee did purchase, acquire, and accept and by this instrument does purchase, acquire, and accept from the Assignor, all of such Assignor's right, title, and interest in, to and under the Trademarks, including all (i) rights to collect royalties and proceeds in connection therewith, (ii) all rights to sue and recover for past, present, and future infringements, misappropriations or other violations of such Trademarks against any persons (regardless of whether or not such claims and causes of action have been asserted by the Assignor), and (iii) rights to protection of interests in the foregoing under the Laws of all jurisdictions, including all registrations, renewals, extensions, combinations and applications for any of the rights referred to above in this Section 1. The Assignor authorizes and requests that relevant trademark offices, entities or agencies in any countries or multinational authorities (as applicable), record Assignee as the owner of the Trademarks.
- 2. Prior to such Trademark Assignment the Assignor was the owner of all right, title, and interest in and to the Trademarks as designated on the Schedule.
- 3. Subject only to the Purchase Agreement and Trademark Assignment, this Confirmatory Trademark Assignment constitutes the entire agreement between the Parties and supersedes any prior understandings, agreements, or representations by or between the Parties, written or oral, to the extent they relate to the Trademarks.
- 4. This Confirmatory Trademark Assignment shall be binding upon Assignor and all of Assignor's successors and assigns, and shall be binding upon and inure to the benefit of Assignee and its successors and assigns.
