

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which the parties hereby acknowledge, Assignor does hereby assign, grant, and convey to Assignee all right, title, and interest in and to the Marks, along with all registrations or pending applications to register the Marks, the goodwill of the business symbolized by the Marks, and the right to sue for past infringement of the mark. Assignor will execute any documents necessary to transfer ownership, title, and registration of the Marks to Assignee.
