RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is effective as of December 15, 2023 and is given by CIBC Bank USA, with principal offices at 120 S LaSalle St, Chicago, IL 60603, in its capacity as administrative agent (“Administrative Agent”) for the benefit of the financial institutions (the “Lenders”) that are parties to the Credit Agreement referenced in each of the (i) Trademark Security Agreement by and between Administrative Agent and MWH Constructors, Inc., a Delaware corporation (“MWH”), dated as of November 2, 2018 (the “MWH Security Agreement”), and (ii) Trademark Security Agreement by and between Administrative Agent and Methuen Construction Co., Inc., a Massachusetts corporation (“Methuen”; MWH and Methuen are each referred to herein as a “Grantor” and collectively as the “Grantors”), dated as of September 30, 2021 (the “Methuen Security Agreement”; the MWH Security Agreement and Methuen Security Agreement are each referred to herein as a “Security Agreement” and collectively as the “Security Agreements”).

WHEREAS, pursuant to the Security Agreements, made by each Grantor in favor of Administrative Agent, a security interest was granted by the respective Grantor to Administrative Agent in the Trademark Collateral as those terms are defined in each Security Agreement, including without limitation those items listed on Schedule 1 hereto;

WHEREAS, the (i) MWH Security Agreement was recorded in the Trademark Division of the United States Patent & Trademark Office on November 2, 2018, at Reel 006513, Frame 0985, and (ii) Methuen Security Agreement was recorded in the Trademark Division of the United States Patent & Trademark Office on October 1, 2021, at Reel 007440, Frame 0385; and

WHEREAS, Grantors desire Administrative Agent to release, discharge, terminate and cancel its lien on and security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Administrative Agent, on behalf of the Lenders, hereby terminates, releases, and discharges unto Grantors the continuing security interest in, and any other interest Lenders may have in, Grantors’ right, title and interest in, the Trademark Collateral.

The Administrative Agent authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.

This Release and its rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with the laws of the State of Illinois.

Capitalized terms used herein without definition have the meanings given to them in the applicable Security Agreement.
