TERMINATION AND RELEASE OF
SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY is made as of December 18, 2023 (this "Release") by Silicon Valley Bank, a Division of First-Citizens Bank & Trust Company (successor by purchase to the Federal Deposit Insurance Corporation as Receiver for Silicon Valley Bridge Bank, N.A. (as successor to Silicon Valley Bank)) (in such capacity and with its successors and permitted assigns, the "Administrative Agent") in favor of The Black Tux, Inc., a Delaware corporation (the "Grantor").

RECITAL

WHEREAS the Grantor granted to Administrative Agent under an Intellectual Property Security Agreement dated as of August 21, 2019 (the "Security Agreement"), a security interest in the certain copyrights, trademarks, registrations and applications of the Grantor including the copyrights, trademarks, registrations and applications set forth in Exhibit A to this Release (the "Intellectual Property").

WHEREAS the Grantor has no outstanding obligations to Administrative Agent under the terms of the Security Agreement, Administrative Agent has agreed to release all of its security interest in all of the Grantor's right, title and interest in, to and under the Intellectual Property, and reconvey any and all rights in the Intellectual Property to the Grantor, including the copyrights, trademarks, registrations and applications set forth in Exhibit A.

AGREEMENT

Now therefore, in consideration of good and valuable consideration, receipt of which is hereby acknowledged, Administrative Agent agrees that it hereby terminates, releases, reconveys and relinquishes all of its right, title and interest in, to and under the Intellectual Property and reassigns to the Grantor, without warranty or recourse, any and all right, title or interest it may have in such Intellectual Property, including the copyrights, trademarks, registrations and applications set forth in Exhibit A.

Administrative Agent hereby authorizes and requests that the United States Commissioner of Patents and Trademarks and any other applicable officer in any successor office or any similar office in any other country record this Release.
