**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “Release”) is made as of June 20, 2023 (“Effective Date”) by BDTCP Investments 2018, LLC, Byron D. Trott, and The Renker Family Trust dated April 23, 1993 (each a “Secured Party” and, together with their respective successors and assigns, the “Secured Parties”) in favor of TR Holding, LLC and TR Apparel, LLC (each a “Grantor” and, together, the “Grantors”).

**WHEREAS**, pursuant to the terms and conditions of that certain (i) Intellectual Property Security Agreement by and between Grantors and Secured Parties dated July 28, 2020 (the “2020 Intellectual Property Security Agreement”) and (ii) Intellectual Property Security Agreement Supplement by and between Grantors and Secured Parties dated November 8, 2022 (the “2022 Intellectual Property Security Agreement”, together with the 2020 Intellectual Property Security Agreement, collectively, the “Intellectual Property Security Agreements” and each, an “Intellectual Property Security Agreement”), each Grantor granted to Secured Parties a security interest in and continuing lien on all of such Grantor’s right, title and interest in, to and under all of the Intellectual Property Collateral (as defined in the 2020 Intellectual Property Security Agreement) (which, for the avoidance of doubt, includes all of the Patents and Trademarks set forth on Schedule 1 of the 2022 Intellectual Property Security Agreement);

**WHEREAS**, (i) the 2020 Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office (“PTO”) for Trademarks on July 30, 2020, at Reel 7025, Frame 0466 and for Patents on July 30, 2020, at Reel 053357, Frame 0967 and (ii) the 2022 Intellectual Property Security Agreement was recorded with the PTO for Trademarks on November 21, 2022 at Reel 7926, Frame 0371 and for Patents on November 21, 2022 at Reel 061840, Frame 0330.

**WHEREAS**, Grantors have paid all of its outstanding indebtedness to Secured Parties.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. **Release**. Each Secured Party hereby terminates and cancels each of the Intellectual Property Security Agreements, and hereby (i) terminates, cancels and releases its security interest in and continuing lien on, and any and all other rights, liens and security interests that it has in, to and under all of each Grantor’s right, title, and interest in, to, and under Intellectual Property Collateral, and (ii) reassigns, grants and conveys to each Grantor any and all right, title, or interest each Secured Party has in, to, or under the Intellectual Property Collateral, in each case, including, without limitation, the Intellectual Property Collateral referred to on Schedule 1 attached hereto.
2. **Recordation**. Each Secured Party authorizes and requests that this Release be filed and recorded with the PTO or any other applicable government office.
3. **Further Assurances**. Secured Parties shall, at Grantors’ expense, take further actions, and provide to Grantors, Grantors’ successors, assigns or other legal representatives, cooperation and assistance (including, without limitation, the execution and delivery of any

and all documents or other instruments), in each case reasonably requested by Grantors to more fully and effectively effectuate the purposes of this Release.

4. Governing Law. This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted with, the laws of the State of New York.
